

A Personal Development Plan to support dental antimicrobial stewardship

The personal development plan (PDP) is used to help you identify your Continuing Professional Development (CPD) needs for your cycle. You will create a plan for maintaining and developing your skills and knowledge within your field of practice and relate this to the General Dental Council's (GDC's) development outcomes. The GDC's *plan, do, reflect, record* model encourages you to think proactively about your professional needs, field of practice and the GDC Standards for the Dental Team before embarking on CPD activity.

All health workers have an important role to play in supporting the appropriate and judicious use of antimicrobials. The Department of Health & Social Care Act 2008: Code of Practice on the prevention and control of infections and related guidance was updated in December 2022. This is relevant to all members of the dental team and includes guidance on Antimicrobial Stewardship in Criterion 3, which states the requirement for: 'Appropriate antimicrobial use and stewardship to optimise outcomes and to reduce the risk of adverse events and antimicrobial resistance.' Staff responsible for prescribing, supply, and administration, relating to the use of antimicrobials may find the following topics useful:

- Clinical oral microbiology including the efficient diagnosis and management of oral and maxillofacial infections.
- The importance of prudent prescribing in tackling antimicrobial resistance.
- Best practices for prescribing to support safe and effective prescribing, administration, and monitoring of antimicrobial therapy.
- Non antimicrobial use of antibiotics.
- Non-human health uses of antimicrobials.

(N.B. Dental Hygienists and Dental Therapists can independently supply or administer certain medicines for their patients' dental needs under Patient Group Directions, but this cannot be used for antibiotics).

Please note this example is not intended to demonstrate a full PDP, but to give an example of how you may plan CPD activity relating to dental antimicrobial stewardship over the five year cycle. You will need to amend it to suit your role and the patients you treat.

Personal Development Plan

All dental registrants who are an independent prescriber are recommended to include:

The Antimicrobial Prescribing and Stewardship Competencies can be used by any independent prescriber to help develop their prescribing practice. You can use it at any point in your professional development in relation to prescribing antimicrobials.

Domain 1. Person-centred care

Domain 2. Infection prevention and control

Domain 3. Antimicrobial resistance and antimicrobials

Domain 4. Prescribing antimicrobials

Domain 5. Antimicrobial stewardship principles

Domain 6. Monitoring, learning, and interprofessional collaborative practice

Under Domain 1 all prescribers caring for patients with (suspected) infection must involve the patient/carer in shared decision making when agreeing and implementing a management plan to ensure patient-centred care. Developing skills in communication and supporting behaviour change will be an important part of your PDP.

To understand your level of competence it is necessary to undertake an honest assessment of your current level of knowledge and skills and your ability to apply them in practice.

It will be helpful to undertake an audit regarding prescribing in your practice. Clinical audit and peer review activities on these topics may be considered as part of a dental professional's CPD. You can seek the help of others (for example, your colleagues, peers and/or your manager) in this assessment. Once you have a realistic assessment of your own level of knowledge, skills, and competence, you will be able to identify your learning needs and how these can be met.

As your learning and development progresses, you will need to revisit the competences and continue to assess yourself to identify your progress in achieving all of the competences. Under Domain 6 this should be a collaborative practice with colleagues and other health professionals.

Training and education

There are a number of educational / training resources currently available to support prescribers. Training and education providers such as NHS England Workforce Training and Education (formerly Health Education England) will also provide opportunities for learning at local events or online webinars.

E-Learning for Healthcare

All e-Learning for Healthcare courses are free of charge. If you are not already registered with e-Learning for Healthcare, you will need to do this by accessing the e-Learning for Healthcare home page: https://www.e-lfh.org.uk/. Once logged in, the full list of programmes is available on the e-LfH Hub "Full Catalogue" page. Once you have completed any of the above courses, you must first generate a course completion certificate from the e-LfH Hub.

Following this you must complete the relevant Enhanced CPD form, referring to the course completion certificate. The Enhanced CPD forms can be accessed from the bottom of the "Dentistry" page of e-LfH in the "Enhanced CPD" section https://www.e-lfh.org.uk/programmes/dentistry/. Please note that both the relevant course Enhanced CPD form and the accompanying e-LfH Hub course completion certificate should be kept as evidence in your records to demonstrate you have completed verifiable CPD, should the GDC request it.

The British Association of Oral Surgeons (BAOS) has developed an Antimicrobial Stewardship e-learning resource for oral health professionals to test their knowledge of antibiotic prescribing. It is **FREE** to take and consists of three modules of clinical scenario-based quizzes, each of which provides a printable e-certificate of one hour's verified CPD upon successful completion. Feedback is provided along the way, with the aim that by the end of the modules, participants will be able to demonstrate application of the principles of sound antimicrobial stewardship to the clinical scenarios.

It is complemented by a Massive Open Online Course (MOOC) developed in partnership with the British Society for Antimicrobial Chemotherapy to teach healthcare professionals (with a special focus on dental teams) about the importance of antibiotic stewardship. Continuing Professional Development (CPD) Activity Log

For any CPD to be considered verifiable, the activity must be recorded on your activity log, and you must have collected corresponding evidence (e.g., certificates and mapping documents, if required).

As part of your CPD record for the GDC, you need to keep a log of all activity you have undertaken, which must include the following details:

- The **title** and **description** of the CPD activity you completed.
- The date it was undertaken.
- The number of hours, as shown on the evidence of completion (e.g. certificate) provided by the course provider
- The GDC's development outcome(s) achieved from each CPD activity.

It should also include a reflective element, or an indication that reflection has taken place.

Reflection

Reflection is an important process for you to evaluate the impact of your CPD activity, taking some time to review and reflect on your activities allows you to assess what benefits you have gained and how you have implemented your learning. Activity should be undertaken consistently and recorded throughout your cycle. A complete CPD record includes your log of activity with development outcomes linked to each activity, your personal development plan, and the evidence you have collected from each activity. You must submit your annual statement each year to the GDC, and you will be notified to make your CPD statement when you get your annual renewal notice.
