These reforms mark a significant step in improving both **access to NHS dentistry** and the **quality of care** patients receive. They respond to concerns about contractual arrangements that limited optimal clinical care delivery. Several reforms take effect from **1 April 2026**, with further changes to complex care, dentures and discretionary payments to follow later in 2026.

Urgent Care — New Requirements & Payments

Calculating Your Required Number

Formula: $(RCV \div £10,000) \times 11 =$
Required Treatments
Round up to nearest whole number

RCV = NACV or NAAV minus:
Orthodontic + Sedation +
Domiciliary + Public Health
payments

Example:

RCV £30,000 → $(30,000 \div 10,000) \times 11 = 33$
treatments

RCV £510,500 → $(510,500 \div 10,000) \times 11 =$
561.55 → **562 treatments**

With Required Number

£15 fixed credit per required treatment
(monthly) + £60 activity credit per urgent
treatment delivered (up to required number)

£75

Above Required Number

£75 activity credit per urgent treatment
delivered above the required number

£75

Without Required Number

£75 activity credit per urgent treatment
delivered (practices with <100 UDAs)

Note: Commissioner can reduce requirement
by up to **15%** between 30 Oct–31 Mar if need
is demonstrably low, to enable funding for
UDC to be transferred to general care.

Preventive Care Changes

4 Fissure Sealants — Re-banded to Band 2

From 1 April 2026, all fissure sealants are Band 2 (previously Band 1). Supports use in children with a history of decay.

Band 2a — Up to 2 teeth **3 UDAs**

Band 2b — 3 or more teeth **5 UDAs**

Claim as Band 2 via Contract Management and Payment System as usual. UDAs count toward contract delivery.

Clinical Guidance : Use of Fissure Sealants

- For high risk children (typically linked to caries risk and previous experience of caries)
- Use resin based fissure sealants
- Applied to permanent molars on eruption (or as soon as you see a patient for the first time who is at high risk of caries)

5 Fluoride Varnish by Dental Nurses

New Band 1 standalone course — suitably competent dental nurses can apply fluoride varnish to children (under 16) without a dental exam.

Standalone Band 1 — per application **0.5 UDAs**

Setup required: Dental nurse must be GDC registered, trained, indemnified, and have a PIN in the Contract Management and Payment System — authorised by Commissioner before first claim. Fluoride varnish must be applied under a Patient Specific Direction (PSD) or prescription.

Claim using codes: 9151 + 9302 + 9160 + 9182 (value 3)

Quality Improvement & Appraisal Funding

£3,400

per year, per eligible practice

Quality Improvement Programme

- Voluntary — sign up by 8 May 2026
- Converted to UDAs at Nominal UDA Value
- Spread monthly from month after sign-up deadline
- Full participation required (no partial payment)
- Must submit year-end declaration by 31 May 2027
- Eligible: GDS/PDS contracts with 100+ UDAs/year

Annual NHS Appraisal Contribution

- For dentists, dental therapists, dental hygienists
- Must deliver min. 2 working days/month NHS care
- Self-declare via Contract Management and Payment System
- Submit within 2 months of appraisal completion
- Max. 1 claim per financial year per person
- Not available to salaried NHS staff (DFT/DTFT etc.)

Ethnicity Recording Changes

Updated Descriptions (Values 1–16)

Existing ethnicity codes have been relabelled to align with 2021 census categories. Key changes include new colon-separated format and updated prefixes.

Value 1 White:

English/Welsh/Scottish/Northern Irish/British

Values 4–7 Now

prefixed "Mixed multiple ethnic groups:"

Values 8–11 Now

"Asian or Asian British: [sub-group]"

2 New Values Added (code 9025)

Two new ethnicity values have been added to the Contract Management and Payment System:

Value 17 White:

Gypsy or Irish Traveller

Value 18 Other

Ethnic Group: Arab

Replacement for 'Patient Declined' (code 99)

Code 99 is replaced by two separate codes to distinguish between different reasons for missing data:

Value 97 Ethnicity

Not Stated (asked but declined)

Value 98 Patient

Ethnicity Unknown (not asked)

Important: All Payments Come From Within Contract Value

UDA credits for urgent care, fissure sealants, fluoride varnish, QI and appraisals are all included within the contract value and are converted to UDAs using the Nominal UDA Value. It is the **Dental Contractor's responsibility to account for this within their contract capacity**. Payments are reflected in pay schedules and the Contract Management and Payment System — no separate invoicing is required.

IMPLEMENTATION

Actions for Dental Practices — 2026

- URGENT CARE**
Receive notification of Required Number from Commissioner by 15 March 2026
- URGENT CARE**
Update Directory of Services profile and patient info leaflet/website by 1 April 2026
- FISSURE SEALANTS**
Begin claiming as Band 2 (not Band 1) from 1 April 2026
- FLUORIDE VARNISH**
Set up dental nurse DCP record and PIN in Contract Management and Payment System before first claim
- QI PROGRAMME**
Decide whether to participate and sign up by 8 May 2026 via Contract Management and Payment System
- QI PROGRAMME**
Identify QI Lead and notify Commissioner of peer group membership by 31 May 2026
- APPRAISALS**
Ensure eligible DCPs have PINs and DCP records in Contract Management and Payment System before appraisal is completed
- ETHNICITY RECORDING**
Update practice system to use new ethnicity codes from 1 April 2026 (especially codes 97, 98 replacing 99)
